REVIEW OF YEAR 2017

Staffing

As of 31 May 2017, the charity has no full-time employees and is run by volunteers.

Activities

- CAS continues to run educational and awareness programs via our education programme termed CASHEW.
- An active team of volunteers continue to manage daily task on site including feeding, walking and cleaning of the CAS Adoption Centre.
- Advocacy of adoption and managing of street and shelter events at community events/shelter tours.
- Community Outreach Programmes – CAS continues to offer financial aid for medical care for pets of senior citizens or lower income owners.
- Adoption drives & fund-raising events held monthly at minimum.
- Stray Management Programme (trapping strays for sterilisation and release thereafter).

Calendar of Events

- Initiating and participating in adoption drives on a monthly basis.
- Fund Raising and raising awareness at events island-wide.
- Community Outreach Programmes (Lion Befrienders/Yong En Home).
- Stray animals' management efforts throughout the year.
- Collaborations with Government organizations (e.g. Participating in AVA Roadshows, Outreach Programmes/MND Huddle/MND Stray Management discussions/MND island-wide TNR Programme/AVA Rehoming exercises).
- Annual General Meeting.

Fund-Raising Event And Activity

CAS also ran the Animals' Day Out 2017 event for its fourth year running. The main goal of the event was to promote awareness and raise funds island-wide to support CAS' causes and programmes. This year, CAS engaged a total of 700 volunteering participants and S\$38,502.38 was raised.

EXPLANATION OF THE PURPOSES FOR WHICH THE CHARITY'S ASSETS ARE HELD

A van was purchased by the Charity in March 2016 for the following non-exhaustive purposes:

- i) Transportation of animals to and fro events' venues, such as AVA Roadshows, adoption drives, etc.
- ii) Transportation of animals to and fro veterinary clinics in need of medical aid or operations, review, vaccinations, etc.
- iii) Transportation of donated items (food, beddings, etc for the animals) to and fro CAS shelter.
- iv) Any other adhoc trips as and when required by the Charity.

FUTURE PLANS AND COMMITMENTS

The Charity plans to source for public donations to refurbish and renovate the new facility at Sungei Tengah. We also target to run fund raisers and awareness events via online platforms every two months to increase our medical-aid support to more shelters and animals' rescuers.
